Congratulations to the youth group for their excellent exhibit at Healthy University at the Plattsmouth Middle School. Not only were they energetic and a big draw for the participants of this annual event but they were presented with the Most Entertaining Exhibitor Award for their efforts.

As I step down as chair of Tobacco Free Cass County, it's time to reflect on what we have been able to do. It has been nine years since I started with the coalition first as the tobacco prevention coordinator and chair then as volunteer chair for the past four years. I remember way back when...I was hired to develop the coordinator position and build grassroots support for tobacco-free environments.

There were milestones along the way that I just knew once those were accomplished, our work would be done. Well, a lot has happened since then. Plattsmouth became the first city in Nebraska to require all retailers to have tobacco products behind the counter or locked in cabinets to prohibit youth access. Many restaurants and venues voluntarily adopted smoke-free air policies then the state of Nebraska adopted the Clean Indoor Air Act which required all workplaces to be smoke-free. Then Cass County commissioners became the first to mandate that all county work sites, vehicles and properties be smoke-free.

But we're still not done. Some school districts still allow tobacco use on their property. Infants and children are still exposed to harmful secondhand smoke and are unable to speak for themselves. There is still much to do. As we continue to make strides in making our communities healthier for everyone, we can look ahead with confidence that our work will continue. Thank you to everyone that has helped me grow as an advocate for tobacco-free environments and for helping our Coalition continue this important work.



Celebrating One Year of Smoke-Free Air

June 1, 2010 marked the first anniversary of Nebraska's law prohibiting smoking in indoor workplaces. Many hours were spent educating the public in preparation for the law's implementation. We believed protecting people from the effects of secondhand smoke while in public places was important, and that many, many Nebraskans supported that decision. But we weren't sure how things were going to play out that first week, that first Nebraska football game, or that first cold winter day.

As it turned out, the implementation of the smoke-free air law was relatively seamless. People continued going to bars and restaurants just like they did before the law went into effect. A big reason we had a successful transition was due to the support from the community and the businesses who did what they needed to do to prepare for the implementation.

I hope that the right to breathe clean indoor air will never be taken for granted. Such a simple concept was a long time coming.
